I acknowledge that I am signing this waiver freely and voluntarily and intend my signature to be a complete and unconditional release of all liability to the greatest extent allowed by law.

I further agree to indemnify and hold harmless the Released Parties from any loss, liability, damage, or costs, including court costs and attorney's fees, that they may incur due to my child's participation in camp activities, whether caused by the negligence of the Released Parties or otherwise.

I have read and voluntarily sign this release and waiver of liability and further agree that no oral representations, statements, or inducements, apart from the foregoing written agreement, have been made.
